ISNI - identifying names of public personas

- International Standard Name Identifier ISO standard 27729
- Identifying the names of 'parties', or more generally, the public 'personas' of persons or organizational entities
- Our target: contributors to creative works and those active in their distribution or exploitation, very broadly defined
- Thus:
 - Total ISNIs assigned since 2012: 14.7 million and counting
 - Natural persons, pseudonyms, noms de plume, stage names ... totalling over 13.1 million identities to date (of which 3 million are researchers)
 - Organizations, units thereof, brand names like publishers, imprints, music labels, film studios, ... about 1.6 million entities to date

Features of an ISNI ID

- The ISNI assigned to the name of a particular persona should be:
 - Unique
 - Persistent
 - Presented in a standard format
 ISNI: 0000 0000 7851 9858 Taylor Swift
 ISNI: 0000 0000 3437 5143 Sonny Boy Williams
 - Accompanied by a minimum basic set of metadata to enable disambiguation
- Additionally, it should:
 - Have its sources of provenance clearly defined
 - Be capable of enrichment with further, extended metadata

What are ISNIs for?!

- Resolving problems of name ambiguity in search & discovery
- Attributing published works accurately to their creators
- Acting as a robust bridge identifier across multiple schemes and domains
- Thus becoming a critical component in linked data and semantic web applications

Yes, but practical uses .. ?

- Identify rights-holders
- Protect rights and their management
- Assist in royalty collection and distribution
- Support scholarship
- Help clarify questions of attribution
- Aid cleanup & enhancement of databases
- Act as bridge ID to facilitate cross-walks, both "manual" and via machine-to-machine LOD and other mechanisms

Integrating ISNI in key workflows

- ISNIs in isolation may already be useful
- Their usage becomes more powerful when they are a routine part of key workflows
- Good examples here include embedding ISNIs in the ONIX files that underpin book publishing operations
 - Functioning already in France, UK, planned in Finland, under discussion in the USA
- Another, this time from the music industry, allows for ISNIs to be included in information exchanges using DDEX standards

Multiple sourcing and collaboration to create an open central resource

- ISNI is above all a collaborative venture
- Members, Registration Agencies and other contributors
- Contributing expertise based on their own specialisms, which can be territorial, linguistic, sector-specific

Information contributed to ISNI

- ISNI assignments have been based on numerous authority files and databases worldwide
- Assertions of identities (effectively, ISNI assignment requests) are matched and rated algorithmically
- Primary role played by ISNI Member organizations and ISNI Registration Agencies
- Smaller proportions start with <u>self-registration of basic</u> <u>metadata by individuals</u> - but still under the responsibility of the respective Registration Agency

ISNI - who does what?

- ISNI Assignment Agency (ISNI-AA)
- ISNI Quality Team (ISNI-QT)
- ISNI International Agency (ISNI-IA) & Board of Directors
- Technical Advisory Committee (TAC)
- Sector-specific Consultation Groups
- The membership of ISNI both regular Members and Registration Agencies (RAGs)

ISNI's Membership

- ISNI's Founding Members, of whom five are still very actively involved
- Currently 70 member organizations, and growing
- 36 regular or founding Members
- 39 <u>Registration Agencies or "RAGs"</u>
- Located so far in 25 countries
- But coverage is world-wide
- Interest remains high: active pipeline of prospect RAGs and the most recent joiner signed up last Friday!

Creative sectors using ISNI

- Interesting and exciting to see ISNI's uptake across various sectors
- Initial interest was strongest in the realm of Libraries, which remain numerically the biggest contributors and users
- More recent broadening out into areas of music, rights and copyright management, book publishing and the research sector
- Expressions of interest from further afield, including film/TV, photography, patent management

Generic challenges/sector specifics

- Reassuring that many issues or challenges have great generic similarities between the sectors (unique identification, disambiguation, de-duplication, ...)
- But to maintain and reinforce ISNI's relevance, we must listen and communicate with the user communities
- Creation of ISNI Consultation Groups (four so far):
 - Libraries
 - Music
 - Book publishing
 - Research sector

Challenges and opportunities

- Diverse user communities, each expecting facilities and approaches with which they are familiar
- Challenges of scale, driven by increased adoption
- Demands for new facilities or mechanisms
- Additional formats for ingest and output
- Services that are relatively new to ISNI

First priority, keeping the lights on!

- Submission of carefully curated authority files
- Supported by reference to creative works with which the data subjects are/were associated
- Powerful matching algorithms and disambiguation
- Maintenance and update of records as necessary
- Dissemination of the ISNIs into the supply chain

How to interact with ISNI data

- Importantly, ISNI is an open standard and the database of ISNI identifiers is largely open, too
- Whether you come from an ISNI member organization or not, you can:
 - Search the database "manually"
 - Search the database using a simplified API
 - Download single records or data dumps in RDF/XML or JSON-LD
- Member organizations have access to more facilities:
 - Dedicated web interface
 - An API for real-time ISNI assignment requests
 - More complex and unlimited API searches
 - Subscribable extracts from the main database

Further development of ISNI facilities

- Already several mechanisms or routes are available to interact with the ISNI database:
 - APIs for search or for assignment requests
 - Batch loading or matching
 - Web interface/manual input
- Others in progress or under consideration:
 - Exploring possibilities for creating a new API that supports the modification of existing records
 - Deployment of a so-called de-duplication crawler
 - Structural improvements to the database structure
 - Introduction of separate mirrored "production" and "publishing" servers

ISNI and Linked Data, 1

- Building on the various LOD initiatives described yesterday ...
- ISNI has its own plans to contribute LD information
- Resourcing constraints have made it necessary to phase delivery of ISNI's LD plans but progress has been made
- We defined a serialization containing useful subset of ISNI identifiers and metadata, in consultation with the BnF, the PCC in the United States and other interested parties

ISNI and Linked Data, 2

- Phase 1, completed in the Autumn of 2021, made it possible to expose ISNI LD information:
 - Via a number of mechanisms including:
 - Single-record manual download
 - Comprehensive data dumps refreshed twice yearly
 - And so far in two "flavours":
 - RDF/XML
 - JSON-LD
- Phase 2, currently underway, will open up the resource to fully automated content negotiation as well as introducing a reverse proxy for secure and controllable operation

Documentation and support

- Making sure that our technical procedures and facilities are well documented for users (particularly new users) is an ongoing challenge
- Lots of material already exists, as evidenced by the <u>Technical</u> <u>Documentation</u> and other pages of the ISNI website
- During 2022 we have also launched an effort to improve and make more accessible some core advice:
 - Background work underway to create an ISNI Manual
 - Prototypes for series of "how to" mini documents. First one in series about our procedures for on-boarding new members.
 - Considering other best practice descriptions like the Pseudonym handling guide
- Some will continue to be text-based but we are also experimenting with short videos, YouTube clips and other formats

ISNI for organizations

- Much of the traction for ISNI in its first decade has revolved around ISNIs assigned to the names of individuals
- Always envisaged that ISNI could also be used to identify the names of organizations of various sorts, e.g.:
 - Publishers
 - Universities and colleges
 - Commercial or nonprofit companies
 - Publishing imprints or other brands
 - Music labels
- Lots of quiet uptake already (1.6 million org records to date)
- Renewed interest being shown in both the Music, Libraries and Book Publishing Consultation Groups
- And don't forget music groups!

ISNI and other identifiers

- ISNI co-exists alongside a number of other identifier schemes, including IPI, ORCID, ROR, VIAF, and others
- ISNI was explicitly designed to act as a bridge or linking ID, can therefore act in that capacity by bridging between other IDs
- Cooperation between ISNI and ORCID namespace, shared memorandum of understanding, aim for interoperability
- The ISNI database and ISNI IDs assigned are open and public, as well as being persistent
- ISNI assignment requests and their supporting metadata are curated by the submitting RAG

Spreading the word

- Big effort on improved communication in recent years
- We now have a Communications Manager
- Quarterly publication of ISNI News
- Much improved social media presence, though it started from a small base!
- Direct engagement with practitioners and "the interested" via our Consultation Groups and mailing list
